SUBJECT: UN Staff Health and Wellness Survey – Results and Interactive Dashboard

OBJET:

- 1. The Department of Operational Support is pleased to share the results of the UN Secretariat Staff Health and Wellness Survey 2021. The survey, coordinated by the Public Health team in the Division of Healthcare Management and Occupational Safety and Health (DHMOSH), aimed to collect baseline information on the health and wellness status of Secretariat personnel globally. We thank all Secretariat personnel who took the time to contribute to this survey.
- 2. A total of 4,620 (11 per cent response rate) of Secretariat personnel participated in this survey, including personnel from peacekeeping operations and special political missions.
